- "You" the customer and signee
- "We/Us" Ashburton District Council and EA Networks Centre

USE OF FACILITIES:

- You are entitled to use the facilities dictated by your membership type during the normal opening hours of the EA Networks Centre which may be changed at any time by us at our discretion.

TERMS APPLYING TO YOUR DIRECT DEBIT SUBSCRIPTION INCLUDE:

- Direct Debit Enrollment Form should be filled out at the same time
 as the Swim Squad Registration Form. If your child has ended their
 membership after a direct debit has been processed for the week,
 the child's account will be put in credit (or the equivalent solution).
